HRA (Health Reimbursement Account) Assistance and Self-Service Tips

Remember, you always call Aon Retiree Health Exchange for assistance with your HRA account. Your questions about reimbursements and claims status are answered by the YSA (Your Spending Account) team of Aon Retiree Health Exchange. Call 1-844-360-4714. You can also manage all of your HRA reimbursement activities online: <http://retiree.aon.com/adventistretirement>.

On the Aon Retiree Health Exchange website, access your account by clicking the My Account tab in the top, righthand corner. At the bottom of the red drop-down box, click "Health Reimbursement Account - HRA". This will take you to the YSA section of your HRA account.

Options of tasks you can accomplish on the website are:

- View your current HRA balance
- View status of claims you submitted
- View all premium auto-reimbursement amounts set up on your account
- Reduce and turn off a monthly premium amount
- View recent reimbursement activity
- Request your personalized claim form
- Choose how to send your receipts/documentation for a claims submission
 - Directly upload receipts/documentation to submit a claim online
 - Fax or email a claim
- Set up Direct Deposit to receive your reimbursement electronically instead of having a check mailed to you
- View a complete list of eligible expenses

About this time each year we receive 1099-R forms back from the postal service due to a bad/undeliverable address. Keeping a clean address list here in our office can be a challenge. If you are receiving this newsletter, we apparently have a good address for you! But please help us keep you on our list by correcting your address if you move. Remember you also need to make an address correction with the Social Security Office.

If you have moved to a new state or county and need to update your address for your MediGap, Medicare Advantage or Medicare Part D insurance carrier please remember **you must call Aon Retiree Health Exchange first**. They will help you choose a new insurance carrier in the state or county you have moved to. If you don't call

Aon Retiree Health Exchange first, you could unintentionally disenroll yourself from the Aon Retiree Health Exchange plans and thus lose your HRA (Health Reimbursement Account) money for the future.
